THE 70,000 VOLUME COLLECTION IS OPEN TO EVERYONE FREE OF CHARGE, IN OPEN STACKS. DURING THIS YEAR, WORK WAS BEGUN ON A MAJOR DIGITIZATION INITIATIVE. AN EXHIBIT OF ALL THE NEW BOOKS OF POETRY PUBLISHED IN THE UNITED STATES EACH YEAR, THE POETS HOUSE SHOWCASE REPRESENTED WELL OVER 700 PUBLISHERS FROM ACROSS THE COUNTRY.
