THE 70,000 VOLUME COLLECTION WAS OPEN TO EVERYONE FREE OF CHARGE UNTIL ITS MANDATORY CLOSURE DUE TO THE PANDEMIC, THAT CLOSURE WAS EXTENDED DUE TO RENOVATIONS FROM A FLOOD IN LATE 2021. DURING 2022 POETS HOUSE CONTINUED TO COLLECT AND CATALOG MATERIALS FOR SHOWCASE EXHIBIT EVENTS FOLLOWING CONSTRUCTION.
